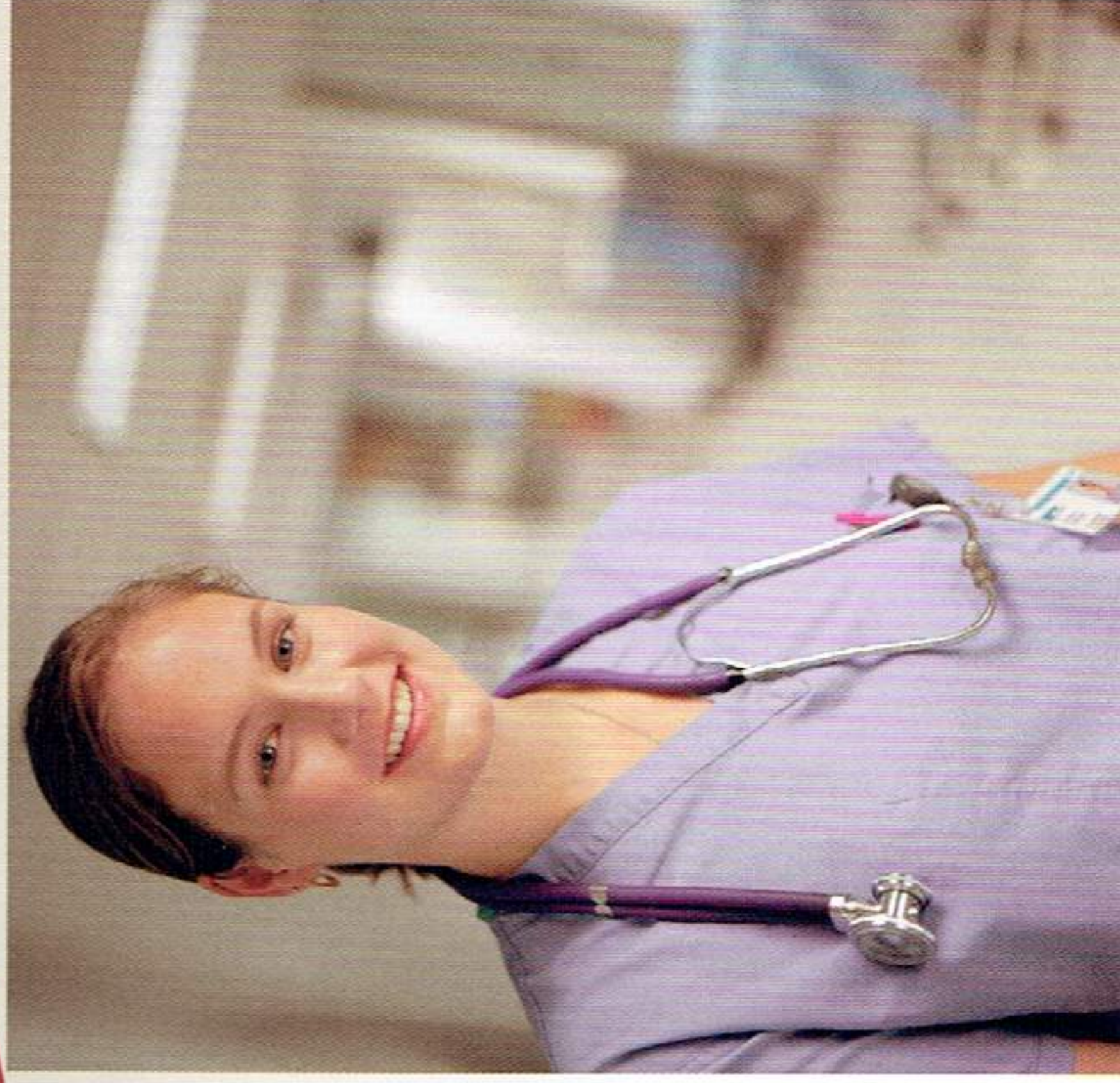

Skilled Nursing

Rehabilitation Services

All therapy includes evaluations and treatment, on-site caregiver instructions and home assessments for safety.

- **Physical therapy**

Improve mobility & ambulation, transfer, gait, balance & coordination.

- **Occupational Therapy**

Develops/Restores Physical Function lost or impaired by disabilities, aging processes, illness, or Physical injury

- **Speech Therapy**

Evaluate patient's speech & language to determine whether communication problems exist & treat patient w/:

- Aphasia
- Dysphagia • Dysarthria • Cognitive impairments & other speech related problems

Home Health Aide

State-certified home health aides: will provide assistance with Activities of Daily Living to include:

- Personal care • Grooming
- Hygiene • ROM • Ambulatory Device assistance and activities of daily living.

Medical Social Services

A medical social worker assist patient in coping with social and emotional difficulties which may result from illness. The medical social worker helps patient and caregiver with community resources, such as meal delivery, transportation, finance, Home Maker and other services.

Medical Equipment Services

Rental or purchase may be covered by Medicare and Medicaid.
